3.1 ACWD Board President James G. Gunther, Topic: ACWD and Water Supply Reliability

Presented on ACWD's water system, supply infrastructure, and water supplies, and the importance of the Delta and ACWD's Aquifer Reclamation Program to combat saltwater intrusion.

3.2 ACWD General Manager Ed Stevenson, Topic: Reliability, Quality, Affordability

Received questions on conservation, affordable housing and water regulation, energy considerations, coordination with Cargill, and recycled wastewater.

Presented on reliability, quality, and affordability, highlighting the Delta Conveyance Project with regards to reliability, PFAS and water quality, and the current rate process and proposed development fees.

Received questions regarding ACWD's smart water meter program and fire hydrant maintenance.

# 1. CALL TO ORDER

Ryan Clausnitzer, ACSDA President, called the meeting to order at 8:19 A.M. President Clausnitzer welcomed everyone to the meeting and extended thanks to Washington Township Health Care District for hosting the meeting and taking the minutes

# 2. WELCOME AND SELF INTRODUCTIONS

The attendees introduced themselves and provided information on the agency that they represented.

# 3. GUEST SPEAKERS

**Kimberly Hartz**, Chief Executive Officer, welcomed everyone and thanked agency representatives for attending the meeting. Kimberly gave a presentation on the history of the Health Care District, plans to become Alameda County's next trauma center, and a construction update on facilities that the hospital plans to build to comply with California state seismic regulations for hospital buildings. The presentation also covered the findings in the recently completed Community Health Needs Assessment

**Elwood Conaway**, Director, Trauma Program, Washington Hospital Healthcare System presented on the history of trauma care in the United States and the steps required for Washington to gain trauma status.

**Marjon Saulon**, Northern California Deputy Regional Director of External Affairs, and **Antonio Isais**, Northern California Regional Coordinator of External Affairs, Governor's Office, presented an infrastructure update for the 2023 legislative session.

#### 4. UPDATES

**Mariellen Faria** provided an update on the Alameda County Local Agency Formation Commission. LAFCO is working on three major initiatives:

- 1. A contract award for countywide water reuse and recycling
- 2. A final report on the unincorporated areas in the county
- 3. A draft report on fire provision

Mariellen added that the strategic retreat for LAFCO will focus on collaboration with partners. Colleen Haley mentioned that only 30 of 58 counties in the state have special district representation in LAFCO. Special districts pay into LAFCO, so there is a focus on special district involvement in LAFCO statewide.

**President Ryan** updated the group on the East Bay Economic Development Agency. ACSDA is now a member of East Bay EDA

Colleen Haley provided an update on the California Special Districts Association. CSDA is focused on four areas currently:

- The California Business Roundtable Initiative. CBRT is reportedly running short of funds for its campaign and is now faced with a competing ballot measure.
- 2. CSDA is working with the Ferguson Group to help member agencies secure funding.
- 3. Guidelines for determining legislative measures to support for special districts.

# 5. BUSINESS

President Ryan asked for a motion to approve the minutes of the July and September, 2023 membership meetings. Sheila Young made the motion and Georgean Vonheeder-Leopold seconded it. The minutes were approved.

Georgean Vonheeder-Leopold, Treasurer, gave the financial report. The deposit for the annual dinner has been paid to Redwood Canyon GC and \$9,413 remains in the bank account.
